What should I give?

The bible encourages us to be generous and cheerful in our giving, and to give what we are able. Old Testament believers gave a tenth of their income, and in the New Testament Jesus commended a widow for giving 100%! Your circumstances will be different from someone else's: pray for wisdom, and decide what you are able to give.

“Out of the most severe trial, their overflowing joy and their extreme poverty welled up in rich generosity. For I testify that they gave as much as they were able, and even beyond their ability. Entirely on their own they urgently pleaded with us for the privilege of sharing in this service to the saints”
2 Corinthians 8:2-4

Our annual budget comes to about £212,500 (including mission giving) and we have 92 adults on the electoral roll.

How can I give?

If you pay sufficient UK income/capital gains tax, fill in the GIFT AID declaration, and we receive (for example) another £25 from the government for every £100 you give. We encourage you to give both to Holy Trinity and to the Mission Agencies we support. You can do this in two ways:

1. By standing order

Fill in the form opposite, stating what amount should go to Holy Trinity, and what amount to mission. (As a guide, people usually give 10-20% of the total to mission). The treasurer will then help you fill in a bank form.

Mission Agencies we support as a Church Family:

- CPAS, working with UK churches
- CMJ, helping Jewish people to know Christ
- Crosslinks, Chris and Ros Howles in Uganda
- STEP youth work in St. Albans schools
- Tearfund, a relief agency
