What should I give?

The bible encourages us to be generous and cheerful in our giving, and to give what we are able. Old Testament believers gave a tenth of their income, and in the New Testament Jesus commended a widow for giving 100%! Your circumstances will be different from someone else's: pray for wisdom, and decide what you are able to give.

Our annual budget comes to about £204,500 (including mission giving) and we have 89 adults on the electoral roll.

How can I give?

If you pay sufficient UK income/capital gains tax, fill in the GIFT AID declaration, and we receive (for example) another £25 from the government for every £100 you give.
